

ARTICLES OF INCORPORATION

of

ARTICLE I - NAME

The name of the corporation is ----- WOOD AND VINYL WORKS INC

ARTICLE II - DURATION

This corporation shall exist perpetually.

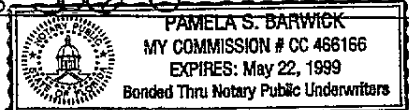
