# ARTICLES OF INCORPORATION

CPU INTERNATIONAL ENTERPRISES, INC

The undersigned incorporators, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of

Incorporation.

#### <u>ARTICLE I. NAME</u>

The name of the corporation shall be CPU INTERNATIONAL ENTERPRISES, INC.

#### ARTICLE II. PRINCIPLE OFFICE

The principle place of business and mailing address of this corporation shall be 1565 N.W. 82nd Avenue, Miami, Florida 33126. Its business shall be carried on in the State of Florida, in the United States of America, and elsewhere, as may be authorized by its Board of Directors or Stockholders.

#### ARTICLE III. **PURPOSE**

The general nature of the business to be transacted by the corporation shall include any or all lawful business with all powers conferred upon Corporations by the Laws of the State of Florida. The corporation may adopt, change, amend and repeal By-laws, not inconsistent with law or its Certificate of Incorporation, for the exercise of its corporate powers, the management, regulation and government of its affairs and property, the transfer on its records of its stock or other evidence of interest or membership, and the calling and holding of meetings of its Stockholders. The corporations may also increase or diminish, by vote of its Stockholders, Shareholders, or members, cast as the By-laws may direct, the number of Directors, managers or trustees, provided, that the number shall never be less than one (1). Further, the corporation may make and enter into all contracts necessary and proper for the conduct of its business.

#### ARTICLE IV. SHARES

The number of shares of stock that this corporation is authorized to have outstanding at any one time is one-hundred (100) shares of (\$1.00) One Dollar par value. Initially, same shall be distributed 50% to Oscar Ramos and 50% to Abel Garcia.

#### ARTICLE V. EXISTENCE.

The corporation shall have perpetual existence.

#### ARTICLE VI. BEGINNING DATE
