1. The following provisions of the Articles of Incorporation of S.C. RICHE REALTY, INC., a Florida corporation, filed in Tallahassee, Florida, be and they hereby are amended in the following particulars:

Article 1 - Name be and it hereby is amended to read as follows:

The name of the corporation is SAUL CHAIM RICHE, P.A.

2. **Article 2 - Purpose of Corporation** be and it hereby is amended to read as follows:

The general purpose of this corporation is to engage in every aspect of the business of rendering the same professional services to the public that a realtor/broker associate, duly licensed under the laws of the State of Florida, is authorized to render.

3. **Article 7 - Corporate Capitalization** be and it hereby is amended to add paragraph 7.5 as follows:

7.5 The shareholders shall only be other professional corporations, professional limited liability companies, or individuals who themselves are duly licensed or otherwise legally authorized to render the same professional realtor/broker associate services as the corporation.

4. All remaining provisions of the original Articles of Incorporation shall remain unchanged.

5. The foregoing amendments were adopted by the Directors and Shareholders of the corporation on June 12, 2006.
