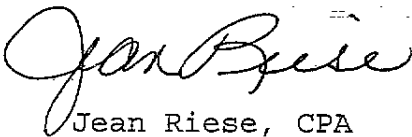

**ARTICLES OF INCORPORATION
OF
MEDICAL CLAIMS, INC.**

ARTICLE ONE

The name of the corporation is: MEDICAL CLAIMS, INC.
