## ARTICLES OF INCORPORATION KAP MANAGEMENT, INC.

TATE OF THE SECRETARY In compliance with the requirements of Florida Statutes, Chapter 607, the undersigned, be a natural personal and acting as Incorporator of a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

#### ARTICLE ONE

#### **NAME**

The name of the corporation is:

KAP MANAGEMENT, INC.

#### ARTICLE TWO

#### PRINCIPAL OFFICE/MAILING ADDRESS

The principal office and mailing address of the corporation shall be:

4338 Mariner Road Bonita Springs, FL 34134

### **ARTICLE THREE SHARES**

The maximum number of shares the corporation is authorized to issue is one hundred (100) shares all of which shall be common stock, all of one class.

#### ARTICLE FOUR PRE-EMPTIVE RIGHTS

Each shareholder of this corporation shall have the first right to purchase shares (and securities convertible into shares) of any class, kind or series of stock in this corporation that may from time to time be issued (whether or not presently authorized), in the ratio that the number of shares held at the time of issue bears to the total number of shares outstanding. This right shall be deemed waived by any shareholder who does not exercise it and pay for the shares preempted within thirty (30) days of receipt of a notice in writing from the corporation, stating the prices, terms and conditions of the issue of shares, and inviting the shareholder to exercise these preemptive rights. This right may also be waived by affirmative written waiver submitted by the shareholder to the corporation within thirty (30) days of receipt of notice from the corporation. A holder of preferred

stock that may hereafter be issued shall not, solely because of his or her holdings of preferred stock, have a right to purchase shares of any class that may hereafter be issued by the corporation.

# ARTICLE FIVE REGISTERED OFFICE AND AGENT

The street address of the registered office shall be 4338 Mariner Road, Bonita Springs, FL 34134, and the name of the registered agent at such address shall be Kimberly A.. Pastore.
