ARTICLES OF INCORPORATION

RYAN ELECTRIC, CORP.

We, the undersigned, do hereby associate ourselves together and subscribe these Articles of Incorporation for the purpose of fórming corporation under the laws of the State of Florida, Chapter 607 and subject to the following provisions:

ARTICLE ONE

The name of the Corporation shall be:

RYAN ELECTRIC, CORP.



ARTICLE TWO

This corporation shall have perpetual existence and may engage in any activity or business permitted under the laws of the United States and of the State of Florida.

The general nature of the business to be transacted by this corporation shall be:
