AMENDMENT ADOPTED

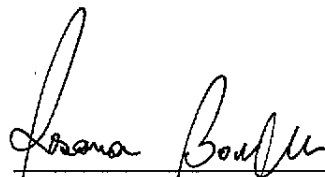
The amendment to the Articles of Incorporation adopted pursuant to Section 607, of the Florida Statutes is as follows:
