OF

ARTICLE I. NAME

The name of this corporation is Florida Advanced Therapy, Inc.

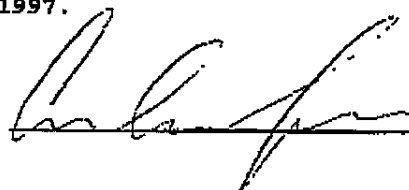
ARTICLE IX. INDEMNIFICATION
