ARTICLES OF INCORPORATION

FIRST: I, IMRAN CHAUDHRY whose post office address is 1655 ACME ST. OCT 31 AM 10: 38 ORLANDO, FL 32805 Being at least eighteen (18) years of age, hereby form a ECRETARY OF STATE corporation under and by virtue of the General Laws of the State of Florida.
