ARTICLES OF INCORPORATION

OF

SLH ENTERPRISES OF BOCA RATON, INC.

The undersigned incorporator hereby files these Articles of Incorporation in order to form a corporation under the laws of the State of Florida.

ARTICLE I. Name of Corporation

The name of this Corporation shall be SLH Enterprises of Boca Raton, Inc.


