

#### ARTICLES OF INCORPORATION

**OF** 

#### CLIP THIS, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, adopt the following Articles of Incorporation:

#### ARTICLE ÖNE NAME

1.01. The name of the Corporation is CLIP THIS, INC.

## ARTICLE TWO DURATION

2.01. The term of existence of the Corporation is perpetual.

### ARTICLE THREE PURPOSE

3.01. The purposes for which the Corporation is organized is to perform all such acts and supply all such services as are commonly performed or supplied by licensed hair stylists, nail technicians, including retail sales of beauty products.

# ARTICLE FOUR CAPITAL STOCK
