**ARTICLES OF INCORPORATION
OF
CLIP THIS, INC.**

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, adopt the following Articles of Incorporation:

**ARTICLE ONE
NAME**

1.01. The name of the Corporation is CLIP THIS, INC.

**ARTICLE TWO
DURATION**

2.01. The term of existence of the Corporation is perpetual.

**ARTICLE THREE
PURPOSE**

3.01. The purposes for which the Corporation is organized is to perform all such acts and supply all such services as are commonly performed or supplied by licensed hair stylists, nail technicians, including retail sales of beauty products.

**ARTICLE FOUR
CAPITAL STOCK**

4.01. The aggregate number of shares that the Corporation has authority to issue is 1000, all of which shall be common shares with par value of \$1.00.

**ARTICLE FIVE
REGISTERED OFFICE**

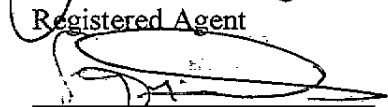

8.01. The Corporation shall commence its existence on October 27, 1997.

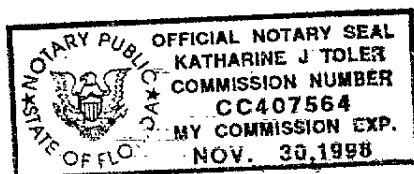

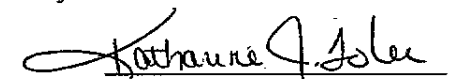
