The undersigned, acting as Incorporator of a corporation understhe Florida Business Corporations Act, adopts the following Articles of Incorporation for such Engrand E. FLORIDA

- 1. Name. The name of the corporation is Farrar Enterprises, Inc.
- 2. Principal Office/Mailing Address. The principal office of the corporation is 13 Westby Close, Bramhall, Stockport, Cheshire, U.K., SK7 2LZ. The mailing address is the same.
