THE UNDERSIGNED, acting as an incorporator of a corporation under the Florida General Corporation Act, section 607.0401, adopt the following Articles of Incorporation:

FIRST: The name of the corporation is Intercarde, Inc.

SECOND: The address of the initial principal office of the Corporation is to be in Palm Beach County, Florida and the period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are to engage in the transaction of any or all lawful business for which corporations may be incorporated under the provisions of the Florida General Corporation Act.

FOURTH: The aggregate number of shares which the Corporation shall have authority to issue is 200 shares, no par value.

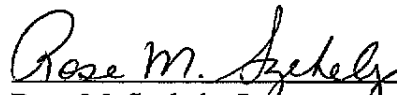
FIFTH: No shareholder of the Corporation shall by reason of holding shares of the Corporation have any preemptive or preferential right to purchase or subscribe to any share of stock of the Corporation now or hereafter to be authorized, or to any notes, debentures, bonds, or other securities convertible into, or options or warrants to purchase, shares of stock of the Corporation now or hereafter to be authorized other than such rights, if any, as the Board of Directors in its discretion from time to time may grant at such price as the Board of Directors in its discretion may fix.

SIXTH: The street address of the initial registered office of the corporation is: c/o 6805 Fountains Circle, Lake Worth, Florida 33467, and the name of its registered agent at such address is Bernard Howard.

SEVENTH: The number of directors constituting the initial board of directors of the corporation is one, and the name and address of the person who is to serve as director until the first annual meeting of the shareholders or until his successors are elected and shall qualify is Bernard Howard, 6805 Fountains Circle, Lake Worth, Florida 33467.

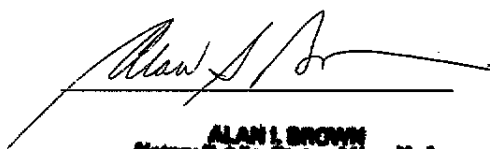
