PURSUANT TO SECTION 607.1006 OF THE FLORIDA BUSINESS CORPORATION ACT, THE UNDERSIGNED CORPORATION ADOPTS THESE ARTICLES OF AMENDMENT.

FIRST: THE NAME OF THE CORPORATION IS WORLD INTERACTIVE NETWORK, INC.

SECOND: THE ARTICLES OF INCORPORATION OF THIS CORPORATION ARE AMENDED BY CHANGING THE ARTICLE NUMBERED III SO THAT, AS AMENDED, SAID ARTICLE SHALL READ AS FOLLOWS:

THE CORPORATION SHALL AUTHORIZE 5,000 CLASS A VOTING COMMON STOCK WITH \$1.00 PAR VALUE AND 5,000 CLASS B NON-VOTING COMMON STOCK WITH \$1.00 PAR VALUE.

THIRD: THE AMENDMENT TO THE ARTICLES OF INCORPORATION OF THE CORPORATION SET FORTH ABOVE WAS ADOPTED ON JANUARY 6, 1998.

FOURTH: PRIOR TO THE ISSUANCE OF SHARES, THE AMENDMENT WAS ADOPTED BY THE INCORPORATORS AND SHAREHOLDER ACTION WAS NOT REQUIRED.
