ARTICLE I - NAME

THE NAME OF THE CORPORATION IS:

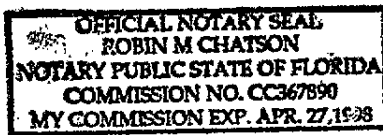
