ARTICLES OF INCORPORATION 97 0CT 31 AM II: 42 OF SECRETARY OF STATE JAGUARS EXPORT AUTO PARTS, INC. LAHASSEE, FLORIDA

<u>FIRST</u>: The undersigned, Piero M. Pejro, whose mailing address is 1629 San Marco Blvd., Jacksonville, FL 32207, being at least 18 years of age, does hereby form a corporation under the general laws of the State of Florida.

SECOND: The name of the corporation, which is hereafter called the "Corporation", is:

Jaguars Export Auto Parts, Inc.

THIRD: The purposes for which this corporation is formed are as follows:

- (1). To buy, sell, store, repair, reconstruct, modify, wholesale, retail, and distribute auto, truck, motorcycle and vehicle parts generally.
- (2). To do such acts and carry on such business as may be permitted by the general corporate laws of the State of Florida.

<u>FOURTH</u>: The address of the principal office of the Corporation in Florida is 5444 Kankakee Blvd., Jacksonville, Fl 32254.

FIFTH: The name and address of the Resident Agent of the Corporation is Piero M. Pejro, 1629 San Marco Blvd., Jacksonville, FL 32233, Duval County. Said Resident Agent is a citizen of the State of Florida and actually resides therein.

SIXTH: The total number of shares of stock which the Corporation has authority to issue is Ten Thousand (10,000) shares having a par value of One Dollar (\$1.00) per share, all of one class, and having an aggregate par value of ten thousand (\$10,000.00) dollars. Each of the said shares shall be common stock entitled to one vote per share.

SEVENTH: The initial number of Directors of the corporation shall be three (3), which number may be increased or decreased pursuant to the By-Laws of the Corporation, but which number shall never be less than one, and the names of the Directors who shall act until the first annual meeting or until their successors are duly chosen and qualified are:

EIGHTH: The duration of the Corporation shall be perpetual.
