ARTICLE I - NAME AND PRINCIPAL ADDRESS

The name of the corporation is Saagar Enterprises, Inc. and the principal address and principal place of business is 18167 US Hwy 19 North, Suite 150, Clearwater, Florida 33764.

ARTICLE II - REGISTERED OFFICE AND AGENT

The address of its registered office in the State of Florida is c/o PATEL, MOORE & O'CONNOR, P.A., 18167 U.S. Highway 19 North, Suite 150, in the City of Clearwater, County of Pinellas, Florida 33764. The name of its registered agent at such address is Sandip I. Patel.

ARTICLE III - PURPOSE


