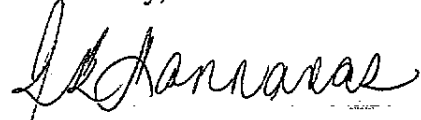

**I.
Name**

The name of the Corporation is SOLAR DATA SERVICES INTERNATIONAL, INCORPORATED, hereinafter referred to as the "Corporation."

**II.
Principal Office**

Purposes
