#### ARTICLES OF INCORPORATION

OF

#### Article I

The name of the corporation is Kim Hatcher Beaumont, C.P.A. P.A.

Article II

The corporation shall have a perpetual existence.

#### Article III

The corporation is organized for the purpose of engaging in the profession of a certified public accountant to render professional services in accounting, tax and financial matters.
