The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, adopt the following Articles of Incorporation:

ARTICLE I • NAME

The name of the corporation shall be:

ARTICLE II • DURATION

The Term of Existence of the Corporation is perpetual

ARTICLE III • PURPOSE

The corporation may transact any and all lawful business for which corporations may be incorporated under the Florida General Corporation Act.

ARTICLE IV • CAPITAL STOCK

The aggregated number of shares that the Corporation has authority to issue is **one hundred**, all of which shall be common shares with no par value.


