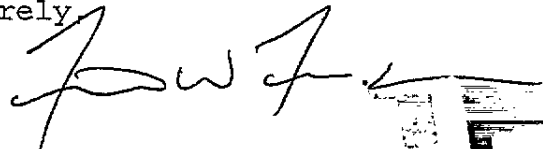

ARTICLES OF INCORPORATION
OF

ARTICLE I. NAME

The name of this corporation is A-FORD-ABLE CARPET & TILE, INC.

ARTICLE II. DURATION

This corporation shall have perpetual existence.

ARTICLE III. PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE IV. CAPITOL STOCK

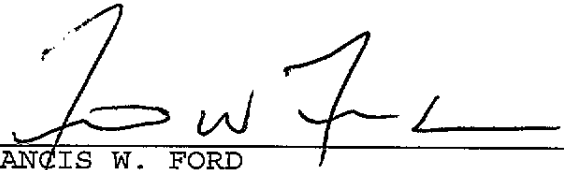

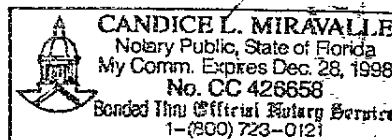

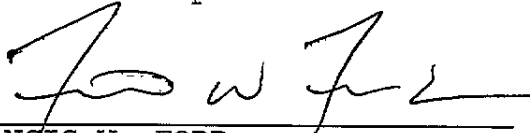
