ARTICLE I. NAME



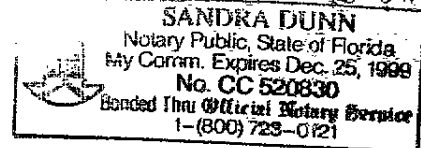


