The undersigned incorporator does hereby make, subscribe, file and acknowledge these Articles of Incorporation for the purpose of organizing a corporation under the Florida Professional Service Corporation and Limited Liability Company Act.

ARTICLE I: NAME OF CORPORATION

The name of the Corporation shall be DANIEL J. CASTILLO, D.M.D., P.A.

ARTICLE II: PURPOSE

The Corporation is formed to engage in every phase and aspect of the practice of law and to transact any lawful business for which corporations may be incorporated under Chapter 621, Florida Statutes, as amended. 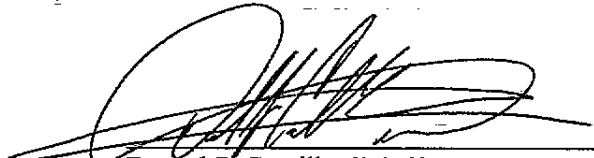

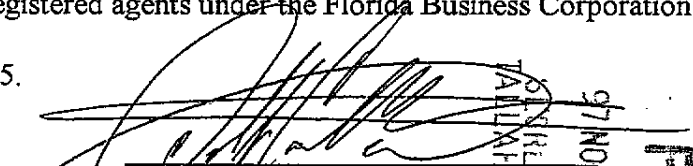
