1. The name of the Corporation is Fantasy World Management, Inc. The date of filing of its original Articles of Incorporation with the Secretary of State was November 3, 1997 (the "Articles").
2. Pursuant to and in accordance with Sections 607.1003 and 607.1006, Florida Statutes, these Articles of Amendment to Articles of Incorporation amend certain provisions of the Articles of Incorporation of this Corporation.
