ARTICLES OF INCORPORATION

The undersigned DONALD E. SCHOLL, does hereby make, subscribe, acknowledge and file these Articles of Incorporation for the purpose of becoming a corporation under the laws of the State of Florida.

ARTICLE I. NAME

The name of this corporation shall be SAIF ENTERPRISES, INC..

ARTICLE II. NATURE OF BUSINESS

The general nature of the business to be transacted is to purchase real estate and any others matters pertaining to such purchases. The corporation is also organized for the purpose of transacting any and all other lawful business and is organized to do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.

ARTICLE III. CAPITAL STOCK

The capital stock of this corporation shall consist of 1000 shares of common stock without par value.
