ARTICLES OF INCORPORATION

OF

PACAMI, INC.

ARTICLES I - NAME and PRINCIPAL PLACE OF BUSINESS

The name of this corporation is PACAMI, INC., and its principal place of business shall be located at 4667 University Drive, Coral Springs, Florida 33067.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of the filing of these Articles of Incorporation with the Department of State.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue one hundred (100) shares of common stock of a par value of One Cent (.01) per share.

ARTICLE VII - DIRECTORS

Initially, this corporation shall have four (4) Director who shall serve until a successor shall be elected/appointed at the first meeting of the stockholders and thereafter this corporation shall have no less than one (1) director constituting the initial Board of Directors. **ARTICLE X - INDEMNIFICATION**

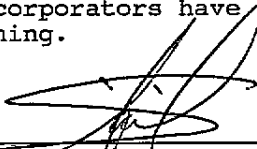

**ARTICLE XI - AMENDMENT**

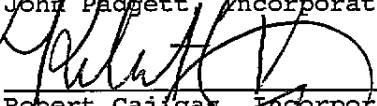
