

ARTICLES OF INCORPORATION
FOR

NUKE IT OF FLORIDA, INC.

The undersigned, acting as the incorporator of a corporation pursuant to the Florida Business Corporations Act, adopt the following articles of incorporation:

ARTICLE ONE: NAME

The name of the Corporation shall be NUKE IT OF FLORIDA, INC.

ARTICLE TWO: PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS

The principal place of business of the corporation shall be 641 Tanager Road, Venice, Florida 34293 and the mailing address of this corporation shall be: P.O. Box 187, Venice, Florida 34284.

ARTICLE THREE: PURPOSE

The purpose for which the Corporation is organized is to engage or transact in any or all lawful activities or business permitted under the laws of the United States, the State of Florida or any other state, country, territory or nation.

ARTICLE FOUR: CORPORATE DURATION

The duration of the corporation is perpetual. The date and time of the commencement of corporate existence is upon filing with the State of Florida.

ARTICLE FIVE: DIRECTORS

The number of directors of the corporation shall be one; provided, however, that such number may be changed by a bylaw duly adopted pursuant to the bylaws of this corporation.

The director named herein as the first board of directors shall hold office until the first meeting of members, at which time an election of directors shall be held. The manner in which the directors are elected or appointed shall be as stated in the By-Laws.



ARTICLE NINE: LIABILITY


