## ARTICLES OF INCORPORATION

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation:

- ARTICLE 7. <u>Amendments:</u> The Corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation or any amendment to them, and any right conferred upon the Shareholders is subject to this reservation.
- ARTICLE 8. <u>Indemnification.</u> The Corporation shall indemnify each Officer and Director, including former Officers and Directors, to the full extent permitted by law.
- ARTICLE 9. <u>Rights of Initial Directors.</u> Each of the initial Directors shall have the right to be a Director of the Corporation as long as that respective Director is a shareholder of the Corporation. In accordance with Section 607.0203, Florida Statutes, the date when corporate existence shall commence is the date of subscription and acknowledgment of these Articles of Incorporation, except that if they are not filed by the Florida Department of State within five (5) business days after the date, then corporate existence shall commence upon filing by the Department of State.

ARTICLE 13. <u>Purposes.</u> The purposes for which the Corporation is organized are the following:

- 13.1 To engage in and transact any lawful business for which Corporations may be incorporated under the Florida Business Corporation Act and other incorporation laws of the State of Florida. No other purpose limits this general purpose in any way.
