The undersigned subscribes to these Articles of Incorporation, natural persons competent to contract, hereby form a corporation under the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation is ADVANTAGE INDOOR, INC., whose principal office address is 2431 ALOMA AVE., SUITE 201, WINTER PARK, FL 32792.

ARTICLE II. NATURE OF BUSINESS
