With this letter, you will find the UBR and a check for \$150. We are requesting abatement of the late filing penalty of \$400. I called the number on the UBR form to discuss the late penalty and was told to send something with the return giving the reasons that the return was not timely filed.

Our office received and forwarded the first UBR report to our clients in the Netherlands. Immediately upon receipt of the second UBR form, I e-mailed the owners.
