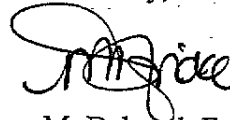

3. Pursuant to the Corporation's Bylaws, a simple majority of the Shareholders is required to dissolve the Corporation.

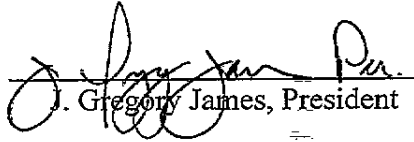
