

ARTICLES OF INCORPORATION OF



The undersigned, acting as incorporator of The Investments Capital Group, Inc. under the Florida General Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation is: The Investments Capital Group,Inc.
