ARTICLES OF INCORPORATION
OF
DAVID ALLEN BUCK, ESQ., P.A.
UNDER THE PROFESSIONAL SERVICE CORPORATION ACT

ARTICLE I - NAME

The name of this corporation is **DAVID ALLEN BUCK, ESQ., P.A.**

ARTICLE II - DURATION

As provided in Florida Statutes, Chapter 607, and Chapter 621, this corporation shall exist in perpetuity.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all business permitted under the laws of the United States and of this state, limited however to those activities allowed under Chapter 621, Florida Statutes, The Professional Service Corporation Act, for all areas of dentistry, orthodontics, oral surgery and such other medical fields in which certification is obtained.

ARTICLE IV - ADDRESS OF CORPORATION

The street address of the principal location of the corporation is 13127 Spring Hill., Spring Hill, FL 34609.

ARTICLE V - CAPITAL STOCK

This corporation is authorized to issue 1,000 shares of Common Stock at \$1.00 par value. Issuance of stock is to be only to those persons qualifying under Chapter 621, Florida Statutes.

ARTICLE VI - PRE-EMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

ARTICLE VII - INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of this corporation is 13127 Spring Hill Drive, Spring Hill, Florida, 34609, and the name of the initial registered agent of this corporation at that address is **DAVID ALLEN BUCK**, Attorney at Law.

ARTICLE VIII - INITIAL BOARD OF DIRECTORS

This corporation shall have one (1) director initially. The number of directors may be either increased or decreased from time to time by the bylaws, but shall never be less than one (1). The names and addresses of the initial director of this corporation are:

ARTICLE XII - INDEMNIFICATION

In addition to any rights and duties under applicable law, the Corporation shall indemnify and hold harmless all its directors, officers, employees and agents, and former directors, officers, employees and agents from and against all liabilities and obligations, including attorney's fees, incurred in connection with any actions taken or failed to be taken by said directors, officers, employees and agents in their capacity as such, except for willful misconduct or gross negligence.
