ARTICLE XI

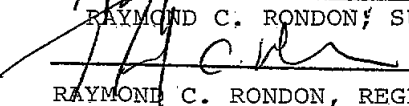

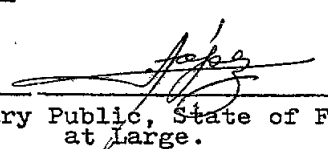

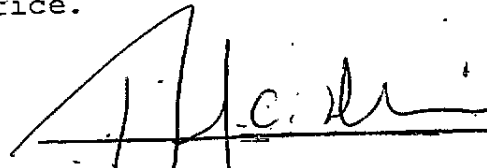
