BOARD OF DIRECTORS

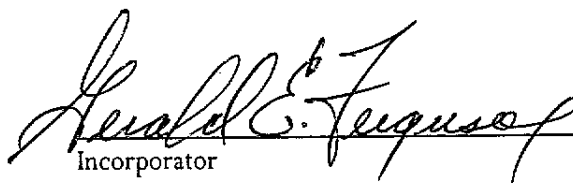

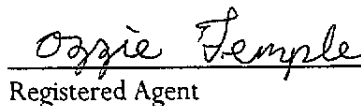
