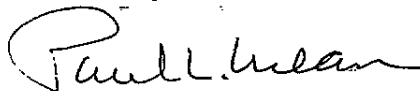

ARTICLE I. CORPORATE NAME.

The name of this corporation is CMI SERVICES OF SOUTHWEST FLORIDA, INC.

ARTICLE II. PRINCIPAL OFFICE.
