ARTICLES OF INCORPORATION

OF

ARTICLE ONE

The name of this corporation is MICHAEL ALLISON, INC., and the mailing address of the corporation shall be 2222 Second Street, Fort Myers, FL 33901

ARTICLE TWO

The date of the commencement of corporate existence of the corporation shall be the date of execution of these Articles.

ARTICLE THREE

The duration of the corporation is perpetual.
