To Whom It May Concern:

On behalf of corporation/taxpayer The Safety & Intelligence Institute, Inc., I.D. number 59-34802473, I am requesting an abatement of all penalties due to the non-filing of its 1998 corporation annual report. The request is being made due to a series of extremely unusual occurrences at the offices of the corporation.

During the past year and a half there have been at least three (3) administrative type individuals involved in the start up of The Safety & Intelligence Institute, Inc. The individuals were entrusted with the responsibility of handling all of the administration functions for the new corporation. It has now been discovered that someone failed to notify management of the annual report filing that we believe was received by the corporation. However, we have no one who will admit to receiving the initial notice, or any follow up notices.

In addition, both businesses were involved in a major facility relocation/refurbishment; and the possibility exists that the paperwork was lost in the move or during any phase of the major renovation work that occurred.

As a result of the excessive turnover and a host of relocation problems, the annual report was not filed on time. The owners of the corporation in question also own Critical Intervention Services, Inc., another Florida corporation. Critical Intervention Services, Inc. has been a Florida corporation since 1992 and has never missed an annual report filing, or any federal or state filing, including all payroll returns.

This same commitment to complying with all filing requirements adhered to by Critical Intervention Services, Inc. also applies to The Safety & Intelligence Institute, Inc..

Again, it was only due to situations beyond the control of management that the annual report was missed. The owners of The Safety & Intelligence Institute, Inc. have retained my office to handle the accounting and administrative functions of the corporation, as I do for Critical Intervention Services, Inc. With this responsibility assumed by my office, no filing violations at the state or federal level are anticipated.

To insure compliance for 1999, attached is a check for \$300.00 to cover the fee for both 1998 and 1999. Again, on behalf of the taxpayer, I thank you in advance for your anticipated cooperation in this serious matter. There was never any intention to not file or file late. The owners of the corporations mentioned above are committed to adhering to all federal and state laws, demonstrated by their clean filing record for Critical Intervention Services, Inc.

Any consideration granted will be greatly appreciated.
