The undersigned subscriber to these Articles of Incorporation is a natural person competent to contract and does hereby form a corporation under the laws of the State of Florida.

ARTICLE I

The name of the corporation is Robinsons-Rent-Rite, INC.

ARTICLE II

The location of its principal office in the State of Florida is 611 E. Sugarland Hwy., Clewiston, Florida, but it shall have the power to establish and maintain branch offices at such cities and towns in the State of Florida and the United States or foreign countries as said corporation may from time to time determine.

ARTICLE III

The corporation may engage in any activity or business permitted under the laws of the United States, State of Florida or foreign country.

ARTICLE IV

The authorized stock of the corporation shall be One Hundred (100) Shares of Common Stock having no par value.

ARTICLE V

The corporation is to exist perpetually.

ARTICLE VI

STRICKLIN, whose address is 6 Myrtle Lane, Lake Harbor, Florida, 33459, does hereby agree to act as the Registered Agent for the corporation for the purpose of accepting service of process for same, and does hereby agree to comply with the laws of the State of Florida, relative to keeping open the office of said corporation.

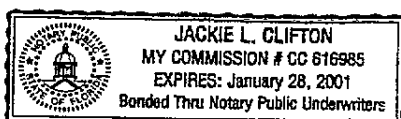
