# ARTICLES OF INCORPORATION OF

The undersigned, acting as sole incorporator, adopts these Articles of Incorporation and forms a profit corporation the "Corporation") under the Florida Business Corporation Act Othe "Act"), as follows:

#### I. <u>Name</u>

The name of the Corporation is Angie's Patio Cafe, Inc.

#### II. Term of Existence

The date when corporate existence will commence is November 3, 1997 in accordance with the provisions of Section 607.0203(1) of the Act, and the Corporation will have perpetual existence thereafter.

#### III. Principal Office

### IV. PURPOSES AND POWERS

The Purpose of the corporation is to do any and all lawful business for which corporations may be incorporated under the laws of Florida.

## ARTICLE XI. Control Share Acquisitions

Pursuant to the provisions of Section 607.0902(5) of the Act, the Corporation elects not to be governed by the requirements or other provisions regarding control—share acquisitions described in Section 607.0902 of the Act. Therefore, the terms and provisions of Section 607.0902 will not apply with respect to any control—share acquisition of any equity securities of the Corporation and the equity securities of the Corporation will have any and all other rights and privileges available under the Act.

#### XII. Bylaws

The power to adopt, alter, amend or repeal bylaws will be vested in the Corporation's Board of Directors.

#### XIII. Indemnification

The Corporation will indemnify any director or officer or any former director or officer, to the fullest extent permitted by law.

#### XIV. Amendment

These Articles of Incorporation may be amended in the manner provided by law.
