Article I - Name

The name of this corporation is Magill Business Consulting, Inc.

Article II - Principal Address

This corporation elects not to be subject to the provisions of Section 607.0902, Florida Statutes, regarding control-share acquisitions.

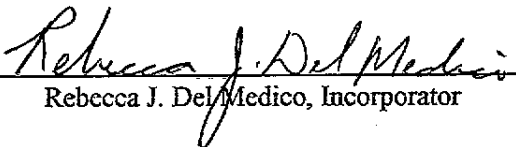
Article XIV - Preemptive Rights
