The undersigned hereby makes, subscribes, acknowledges and these Articles of Incorporation for the files these Articles of Incorporation for the purpose of forming a corporation under the Florida General Corporation Act, and hereby adopts the following Articles of Incorporation.

ARTICLE I

NAME
