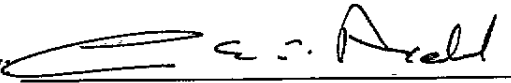

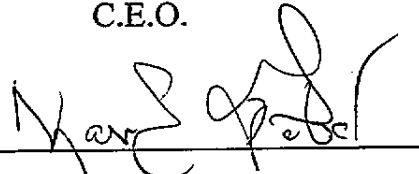
- FIRST:** The name of the corporation is COUSINS ORECK OF PLANTATION, INC. (the "company").
