The undersigned incorporators, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt the following Articles of Incorporation.

#### ARTICLE I

#### Name

The name of the Corporation shall be CARPET BARGAINS SUPERMARKET, INC., hereinafter referred to as the "Corporation".

#### ARTICLE II

# **Principal Place of Business**
