# ARTICLES OF INCORPORATION OF VIPER SECURITY GROUP, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following articles of incorporation:

# ARTICLE ONE - NAME

The name of the corporation is **VIPER SECURITY GROUP, INC.** The mailing address of the corporation is 5522 State Road 54, New Port Richey, Florida 34652.

#### ARTICLE TWO - TERM OF EXISTENCE


