BRIDLE GATE/AUDUBON, INC.

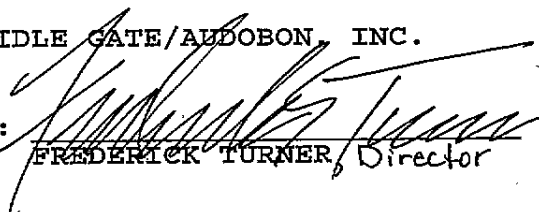
SECOND: The date of the amendment's adoption is November 7,
