Article I Name

The name of the Corporation is Survey Brokers, Inc.

Article II Duration

The Corporation shall commence its existence on November 1, 1997 and shall have perpetual existence.

Article II Purpose

The nature of the business to be promoted and carried on, is to engage in any lawful activity for which Corporations may be organized under the General Corporation laws of the State of Florida. The Corporation is organized for the purpose of transacting business relating to, but not necessarily limited to, surveying, platting, and diagraming various types of real estate property. To arrange for various services relating to the operations of the business as from time to time shall be deemed appropriate. To provide consultation services in the fields related to surveying or diagraming as shall be necessary to the Corporation's clients. To act as a third party in arranging services which may be required by the Corporation's clients or itself. To perform any other activity which shall be deemed appropriate by the Corporation.

Article IV Capitol Stock

The Corporation shall be authorized to issue 1,000 shares of Fifty Cents (\$.50) par value common stock, which shall be designated common shares. The Corporation shall be authorized to issue additional stock , both by class and value, both voting and non-voting stock as the Board of Directors shall designate.

**Article V Initial Registered Agent
And Office**

The street address of the initial registered agent of this Corporation is 501 E. Dania Beach Blvd. City of Dania State of Florida, and the name of the original registered agent at that address is Peter Theodoropoulos.

Article VI Board of Directors




Article X Amendments






