The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I

The name of the corporation is R-TISTIC FURNITURE SERVICE, INC., whose principal place of business is 4260 NW 1st Avenue, Bay #56, Boca Raton, FL 33431.

ARTICLE II

The period of duration of the corporation is perpetual.

ARTICLE III

The purpose or purposes for which the corporation is organized are to engage in any activity or business permitted under the laws of the United States and of this State.

ARTICLE IV

The corporation shall have the authority to issue one thousand (1,000) shares, all of one class of Capital Stock, with a par value of \$1.00 per share.

ARTICLE V

The address of its initial registered office is 9255 SW 2nd Street, Boca Raton, FL 33428 and the name of its initial registered agent at said address is Art Lobe.

ARTICLE VI

The number of directors constituting its initial Board of Directors is one (1), whose name and address is: Art Lobe, 9255 SW 2nd Street, Boca Raton, FL 33428.

ARTICLE VII

ARTICLE VIII

The shareholder(s) shall have the power to adopt, amend, alter, change, or repeal the Articles of Incorporation when proposed and approved at a stockholder's meeting, with not less than a two-thirds vote of the common stock.

ARTICLE IX

The power to adopt, alter, amend or repeal By-Laws shall be vested in the Board of Directors.


ARTICLE X



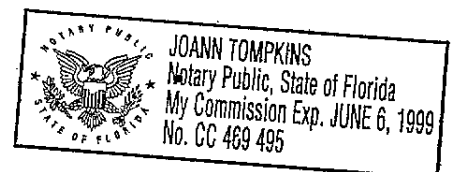
