The undersigned incorporator to these Articles of Incorporation, a natural person competent to contract, hereby subscribes and forms a corporation for profit under the Laws of the State of Florida.

ARTICLE I: NAME

The name of the corporation is: DENISE COOPER ROSS & ASSOCIATES, P.A. and its principal office and mailing address is: 1160 N. Federal Hwy, Fort Lauderdale, FL 33304.

ARTICLE II: NATURE OF BUSINESS


